Board Member Reports

Sandy Warman, President

*Sandy asked for ideas on how to handle recognition of birdies and chippies during the season. She outlined what has been done for at least the past 7 years. Sandy J did some research on what other clubs do. Using those ideas and brainstorming the idea of customized ball marks and/or cash prizes the Board decided on the following:

Customized ball marks (with TLQWGC logo) can be made through a company that Marie Clark has a connection with for \$2.16 per mark. The set-up fee and minimum order of 250 units would come to an initial expenditure of around \$600. With the minimum order, there should be enough markers for 3 years. The logo can then also be used for other things.

We will do a 50-50 raffle at the Welcome Back Party. 50% of the sales will be given out as cash prizes at the party. The other 50% will be used to fund the customized ball mark to be given at the end of the season to everyone who got (and registered) a birdie during Club play.

25 cents of each Sweeps buy-in will go into a "chippie" pot. Anyone who gets a chippie that day will win the pot. Ties will be split. If no one wins, the money will carry over to the next week. (Need to talk about the same procedure for tournaments?)

The Club has not formally recognized Eagles in the past. This will be addressed at next months meeting. *The Facilities Chair responded to Sandy's request about making space for our trophies at the Santa Rosa Club House. He said that nothing will be decided until decisions are made on the remodel of the Club House. <u>ACTION ITEM:</u> Sandy W will monitor any progress.

*Splitting summer sign-ups is working well with some tweaks on how it is presented on the website.

*Jim Wanless will be leaving the end of June. Miguel Rascon will be back to handle summer business.

*Sandy will pay out Sweeps at the General Meeting next season, not weekly. This will help encourage ladies to come to the meeting.

*When researching other Club's websites, Sandy noticed that a number of Clubs offer the ability to have a guest play with a member. It was discussed and generally agreed to use this as a recruitment tool.

Founders Day: This will be a 6/6/6 format with partner alternate shot/best ball/scramble. Also the Holiday Party will be the same day, late afternoon. Sandy W will ask Lyna to handle the planning for the party.

Friendship Game: Helen has handled in the past with the 9-holers. It is our turn to host. Rita will help. ACTION ITEM: Helen to contact the 9-hole Board to be sure they want to do this again.

Senior Club Championship: NEW!! Ladies 70 years and older can choose to play in this Championship Tournament that will run concurrently with the regular Club Championship. The format will the same with 3 rounds and winners each day. The budget has been updated for two trophies.
