#### **STANDING RULES**

# ALL MEMBERS OF THE TRILOGY LA QUINTA WOMEN'S GOLF CLUB PLEASE READ AND THOROUGHLY FAMILIARIZE YOURSELVES WITH THE FOLLOWING STANDING RULES. THEY ARE VERY IMPORTANT.

These Standing Rules may be amended or repealed and at any meeting of the Board of Directors, a quorum being present. A two-thirds (2/3) majority vote is needed.

#### **MEMBERSHIP**

Yearly fees will be billed by the TLQWGC in November which includes membership to the hole-in-one fund. Dues are payable on or before December 31 and are delinquent January 1. A late fee of \$25 will be assessed on January 1.

#### **TLQWGC LADIES DAY**

There will be a designated Ladies Day each week. Online sign-ups will be accepted during a stipulated time period each week. Ladies requesting to play after sign-ups are closed need to sign up on the Wait List on the website. Tee times or Hole assignments and pairings will be posted on the website no later than one day prior to the day of play.

### **Tournament Rules and Regulations**

Determination of the season's major tournaments as well as the rules and regulations that govern each event shall be defined by the elected tournament chair and president positions. Some tournaments may have specific participation requirements that will be communicated to the membership at the beginning of the season and reiterated through the tournament flyers posted on our website. The Tournament chair reserves the right to adjust requirements as dictated by circumstances beyond her control. These include, but are not limited to:

- 1) Prizing eligibility including flighting requirements
- 2) Minimum round requirements for participation, if any
- 3) Tee box determination

4) Tournament format including minimum handicap requirements, or maximum handicap limits

#### **TLQWGC Member Guest Tournament**

Should this tournament be included on the tournament calendar, all players must have a verifiable handicap to participate in the Member Guest Tournament. Guests may be residents of Trilogy La Quinta as long as they are not TLQWGC 18-hole members.

### **Standing Tournament Regulations**

- a) A player may win only one prize. A player who is disqualified forfeits claim to any prize.
- b) Tournaments with entry fees will have designated "no refund" deadlines.
- c) Should this format be selected by the tournament chair for the season, the President's Cup is a single or partner match play tournament played over several weeks. The schedule of dates provided must be adhered to. If you and/or your partner are not able to play your match within the schedule outlined, you must notify the Tournament Chair. If you and your opponent(s) are unable to agree on an alternate date (within the date schedule), the player(s) with the original date conflict will forfeit the match and the opponent(s) will advance to the next level.
- d) In order to play in any TLQWGC tournament all players must have a verifiable handicap.
- e) In the event of ties, the following procedures should be used and stated in advance of each tournament:

### Match Play:

A match which ends up all square will be played off hole by hole until one side wins a hole. The playoff will begin on the original starting hole of the match.

## Stroke Play:

In tournaments where a single player must be the lone winner and if the tournament does not allow the players to continue play until there is a clear winner, ties will be broken using the BACK NINE METHOD of matching

scorecards. If the tying players have the same score for the back nine, the winner will be determined on the basis of the last six holes, last three holes and finally the 18<sup>th</sup> hole.

Players tied for winning positions will receive payouts per the USGA sharing of tying winnings. For instance, if 2<sup>nd</sup> place pays \$50 and 3<sup>rd</sup> place pays \$40, those two amounts will be added together and the \$90 will be split between the two players for \$45 each.

#### **Tournament Prizes**

Any tournaments with both gross and net prizes will pay equal amounts to gross and net winners.

#### **Tournament Golf Committee**

The Golf Committee consists of the Tournament Chairperson, who shall be the Chairperson of the Committee, the Assistant Tournament Chair, Handicap Chairperson, and Rules Committee Representative. It is the duty of the Committee to recommend policy and procedures for all golfing events of TLQWGC, subject to approval of the board and in compliance with the United States Golf Association (USGA) Official Rules of Golf. It shall sit in judgment and make final decisions on any matters of dispute or protests which may arise during or after competition. The Committee shall assist the Tournament Chairperson in pairings, scoring, and checking eligibility of participants for special events.

## **SPECIAL AWARDS**

## **First Time Milestone**

A prize will be awarded for breaking 100, 90, 80 or 70 for the first time at Coral Mountain Golf Club (or our deemed course of record), as long as the game is played with a member of TLQWGC regardless of the time of year. You cannot have picked up or adjusted the score on any hole. All putts must have been holed out. It should be indicated on score card that this was a milestone score.

### **Eagles**

This award is a seasonal event with prizes given for eagles achieved beginning the first golf day of the new season through the last golf day before the Farewell Event. Eagles that are eligible must occur when playing on a sanctioned Ladies Day Event at the Coral Mountain Golf Club (or our deemed course of record). At our Farewell Event recognition and a prize will be given to each person who had an eagle during the season, with a maximum of one prize per person.

### **Birdies**

This award is a seasonal event with prizes given for birdies achieved beginning the first golf day of the new season through the last golf day before the Farewell Event. Birdies that are eligible must occur when playing on a sanctioned Ladies Day Event at the Coral Mountain Golf Club (or our deemed course of record). At our Farewell Event, a birdie marker will be given to each person who had birdies during the season, with a maximum of one birdie pin per person, and an award will be given to the person who has had the most birdies for the season. There is a page on the TLQWGC website for you to record your birdies. Circle birdies on the scorecard and write birdies on top of the card.

## Low Net of the Month/Year

This award is a seasonal event beginning the first golf day of the new season through the last golf day before the Farewell Event and shows an individual's outstanding game of golf. This shall be based on the lowest net score for any sanctioned Ladies Day event played at the Coral Mountain Golf Club (or our deemed course of record). No player is eligible to win this award more than once during a season. All ties will be honored. The awards will be given monthly at the general meeting. Low net for the year will be given a special award at the Farewell event. There is a page on the TLQWGC website for you to record your low net each month. You cannot have picked up or adjusted the score on any hole. All putts must have been holed out.

### **Chip Ins**

This award is a seasonal event with prizes given for chip-ins achieved beginning the first golf day of the new season through the last golf day before the Farewell Event. Chip-ins that are eligible must occur when playing on a sanctioned Ladies Day event at the Coral Mountain Club (or our deemed course of record). A chip-in is defined as any shot that goes in the hole when played from off the putting surface (zero putt). At our monthly general meetings, recognition and a prize will be given to each person who had chip-ins during the prior month. There is a page on the TLQWGC website for you to record your chip-ins (See below). Circle chip-ins on the scorecard and write Chip-In on top of the card.

#### **TLQWGC HOLE-IN-ONE**

Our Hole-In-One fund is included in our annual membership dues. When a member of TLQWGC has a hole in one at the Coral Mountain Golf Club regardless of time of year, and witnessed, we will celebrate her accomplishment at the next Ladies Day event. Drink tickets will be distributed to members present and the Club Treasurer will pay the establishment with our Club credit card not to exceed \$300. The HIO honoree will be responsible to pay the excess. If the hole-in-one fund falls below \$300 the reserve fund will be used to replenish the fund (not to exceed \$1500 per year).

TLQWGC will also recognize the hole in one with an award and her name will be placed on the club plaque.

In the event that play is not occurring at the Trilogy course, we will recognize as follows:

- During a sanctioned event day, recognition as listed above.
- During the playing season at our deemed course of record but outside of league play days, player will receive a pin and will be recognized on the website.

#### **MEMORIAM**

If a member, spouse, or significant other passes away, we will make a donation of \$50 to the charity of their choice or send flowers if no charity is designated.

## **HANDICAP AND POSTING PROCEDURES**

An established verifiable handicap is required of all members and their guests to play in TLQWGC events. It is the responsibility of each member to ensure their scores are posted unless otherwise stated.

Handicaps shall be established, and scores shall be posted according to procedures set forth by the Southern California Golf Association (SCGA).
